Summary/Objective:

Our technician's play a vital role within the Hartung Brother's Kauai organization with the overall goal to produce a reliable supply of highquality seed. The successful candidate will be responsible for executing production plant tasks to ensure all required processes, procedures and production requirements are met. Position will take on several roles based upon field production practices, plant processing requirements and distribution needs. Will be required to monitor, operate, and maintain both plant and field technical production equipment. The successful candidate should be experienced in crop production in a tropical environment. A strong willingness to grow, learn, and change as the organization changes. The capability to make process improvement decisions, work through, and implement novel ideas.

The technician will work closely with the Operations Lead and other departments sharing employees, resources, and information throughout the year to ensure the success of the overall program. Effectively communicate with internal customers and use problem-solving skills to prioritize workload and deliver results. Candidate will have experience working across various areas, managing timelines, and executing tasks.

Essential Duties and Responsibilities:

- Plant activities include but not limited to:
 - o During harvest walking floor, husk and sorting, and forklift operation
 - Post-harvest activities drying, shelling, fumigation, and shipping.
 - Continuous maintenance, repairs, and improvements throughout the facilities.
- Field activities include but not limited to:
 - o In season planting, field notes, cutter/puller operation, fencing, netting, roguing, and detasseling.
 - Harvest moistures, machine harvest and hauling.
- Ability to work independently for long periods of time with limited oversight.
- Electronic based note taking using handhelds, smartphones, applications, and computers.
- Leadership when required possess the ability to lead small groups of seasonal and full-time workers through various field and plant-based tasks.
- Safety and Compliance
 - o Adhere to detailed protocols for safety, compliance, and seed quality standards.
 - o Ensure protocols are in place, trained on and promote safe behaviors and best practices.
 - Make process improvement decisions, work through protocol development, and implement novel ideas.
 - Read and train employees on Owners Manuals for equipment used within the program. Understand and implement the manufacturers recommendations regarding safety, services, regular maintenance, and repairs.
- Flexible work hours especially during peak workload across the site. Able to work long hours or off schedule including evenings, early mornings, weekends, and holidays to ensure targets are met.
- Must have or be able to obtain Private 1 and 2 Pesticide Applicators License.

Expected Hours of Work
